Approve Amendatory Agreement with
Monroe County for Urban County Requalification

WHEREAS, under Title 1 of the Housing and Community Development Act of 1974, as amended, and the National Affordable Housing Act of 1990, the Secretary of the United States Department of Housing and Urban Development, is authorized to make grants to States and units of general local government to help finance Community Development Block Grant (CDBG) program, and

WHEREAS, the County of Monroe is an Urban County qualified for participation in the CDBG program for fiscal years 2027 – 2029, and

WHEREAS, the County of Monroe and the Town of Sweden entered into a Cooperation Agreement on May 21, 2002 (“Cooperation Agreement”), and

WHEREAS, the County of Monroe and the Town of Sweden wish to amend the Cooperation Agreement.

NOW, THEREFORE, BE IT RESOLVED:

- Sec. 1. COOPERATION AGREEMENT shall be amended to include 21 c. to read as follows:
- c. Parties to this Agreement understand and agree that they may not sell, trade, or otherwise transfer all or any portion of CDBG funds to a Metropolitan City, Urban County, unit of general local government, or insular area that directly or indirectly receives CDBG funds in exchange for any funds, credits, or non-Federal considerations, but must use such funds for activities eligible under Title I of the Housing and Community Development Act of 1974, as amended.
- Sec. 2. All other terms and conditions of the Cooperation Agreement shall remain in full force and effect for the upcoming three-year qualification period term dates: October 1, 2026 – September 30, 2029.
- Sec. 3. That the Town Board of the Town of Sweden does hereby authorize the amendment to the Cooperation Agreement between the Town and the County of Monroe for Urban County Requalification.
- Sec. 4. That the Supervisor is hereby authorized to execute all necessary documents.
- Sec. 5. That this resolution shall take effect immediately.
