Authorizing Purchase/Repairs of Gorman
Rupp V6A60-B

WHEREAS, The Highway Superintendent has determined that the Gorman Rupp V6A60-B rotating assembly at a Town of Sweden sewer pump station requires repair and replacement to ensure continued proper operation; and

WHEREAS, The cost of said repair and replacement is \$13,025, as quoted by Siewert Equipment, 175 Akron Street, Rochester, NY 14609; and

WHEREAS, Siewert Equipment is the sole source provider for this equipment; and

WHEREAS, funds for this repair are available and budgeted in Sewer Funds SS.8120.400 and SS4.8120.400;

WHEREAS, the Highway Superintendent recommends accepting the quote from Siewert Equipment for thirteen thousand and twenty-five dollars (\$13,025).

NOW, THEREFORE, BE IT RESOLVED:

Sec 1. That the Town Board of the Town of Sweden hereby authorizes the repair and replacement of the Gorman Rupp V6A60-B rotating assembly for the sewer pump station by Siewert Equipment at a cost of thirteen thousand and twenty-five dollars (\$13,025).
