This project will provide safety improvements to reduce identified crash patterns at the intersection. The project proposes to reconstruct the intersection into a modern roundabout. Other improvements include guide rail, drainage repairs, and sign upgrades. The project is currently scheduled for construction in 2027 and 2028.

NYS DOT design staff will be available to explain the project and answer questions. There will be no formal presentation.

A quorum of Sweden Town Board members *might* be present, but the Sweden Town Board will not convene or take any action. Members will be attending as observers.

PROJECT LOCATION

Intersection of State Routes 31 / 31A and County Route 236 (Redman Road) in the Town of Sweden, Monroe County.

PROJECT OBJECTIVE

Provide safety improvements to address identified crash patterns at this intersection.

PROPOSED IMPROVEMENTS

- Reconstruct the existing intersection with a modern roundabout.
- Install new signs and pavement markings.
- Install a new closed drainage system.

RIGHT-OF-WAY IMPACTS

ROW Acquisitions are anticipated along the project corridor.

ESTIMATED CONSTRUCTION COST

Approximately \$7.6 million

CONSTRUCTION SCHEDULE

Start Construction – Summer 2027
End Construction – Winter 2028

WORK ZONE TRAFFIC CONTROL

- **Phase 1 (2027) – Utility Relocations** - Traffic will be maintained on-site with daily flagging operations.
- **Phase 2A (2028) – Roundabout Construction** – Full closure of Route 31 (Redman Road) & EB direction only on Route 31. Route 31 / 31A WB Direction & County Road 236 (Redman) will remain open to traffic. Off-site detours will be posted. ([see reverse side](#))
- **Phase 2B (2028) – Roundabout Construction** – Full closure of County Road 236 (Redman) & EB direction closure only on Route 31/31A. Route 31 / 31A WB Direction & Route 31 (Redman Road) will remain open to traffic. Off-site detours will be posted. ([see reverse side](#))
- Access to all properties within the project limit will be maintained throughout construction

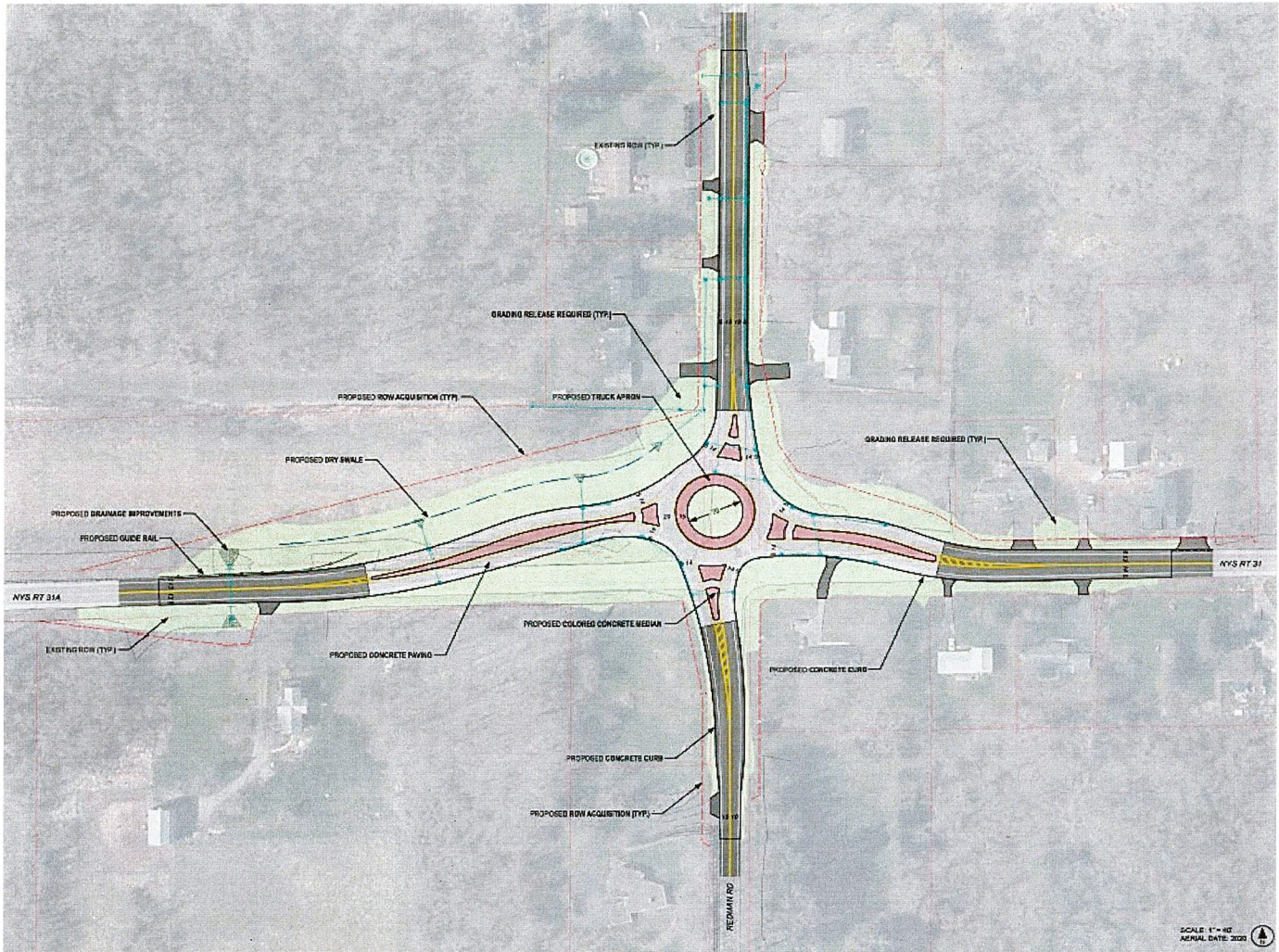

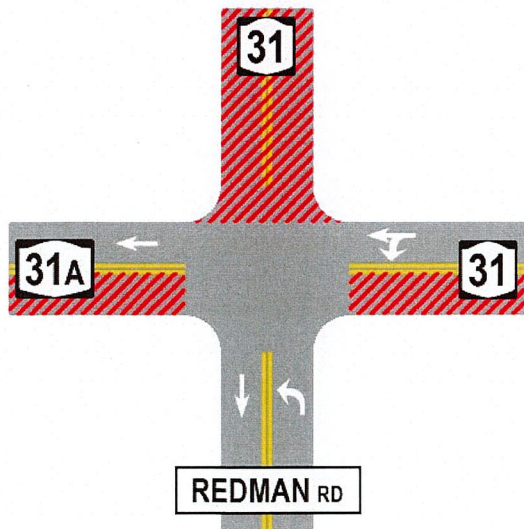
