

A regular meeting of the Town Board of the Town of Sweden was held at the Town Hall, 18 State Street, Brockport, New York, on Tuesday, November 25, 2025.

Town Board Members present were Supervisor Patricia Hayles, Councilperson Scott Maar, Councilperson Adam Staskiewicz, and Councilperson Gary Sullivan. Councilperson Tyler Sharpe was absent. Also present were Finance Director Hiedi Librock, Superintendent of Highways Brian Ingraham, Town Attorney Jim Bell, Assessor Tammy Baker, Building/Code Enforcement Officer Robert LaPoint, BCM Consultant Terry Ekwel, Town Clerk Karen Sweeting, James Oberst and Scott Mattison from MRB Group, and Attorney Amy Kendall.

Supervisor Hayles called the meeting to order at 6:00 p.m. and asked everyone present to say the Pledge to the Flag and remain standing for a moment of silence for all the people who put themselves in harm's way for our safety, including all those in the armed services and our first responders.

CORRESPONDENCE:

No correspondence noted.

REPORTS OF BOARD AND DEPARTMENTS:

Supintendent of Highways Brian Ingraham reported the following:

- Leaf pickup will continue through next week
- Preparing trucks for snow and ice control
- Placing snow fence, approximately 2 miles
- Equipment maintenance
- Mulching leaves at the cemetery

Finance Director Hiedi Librock reported that the budget has been submitted to the County and all figures have been verified. Open enrollment for health insurance has closed and final figures will be available for the board soon.

Councilperson Staskiewicz reported that the Halloween event was a success. The winter brochure was delivered November 8th and will be the last included in the Westside News, all future brochures will be digital with few hard copies available at the Sweden Clarkson Community Center. The Veterans Day event was well attended, and the Holiday event is

scheduled for December 11th. Registrations have begun for spring and summer baseball and soccer. The senior potluck and Christmas caroling is scheduled for December 10th.

Councilperson Sullivan reported that the storage building at the Sweden Clarkson Community Center has been completed. They are replacing the outfield fencing on Field 7 at the Town Park. The kick wall was painted, and the sponsorships were placed on the wall. Snow fence is being installed at several locations at the park. Lodge rentals are strong. The sledding lean-to at the Sweden Clarkson Community Center is ready for use.

Councilperson Maar reported that the library has received some additional funding and they are starting their long-range planning.

Supervisor Hayles reported the following:

- The NYAOT annual newly elected official training is being held in Corning January 21 – 23, 2026 and the annual meeting is February 15 – 17, 2026 in New York City. (Supervisor Hayles plans to attend pending board approval.)
- Veterans Day event was wonderful. A 101 ½ year old veteran attended and shared their story.
- Ace Cleaner hearing scheduled for tonight. Rochester Gas & Electric will shut off utilities to prepare for demolition. County Legislator Smith was instrumental in coordinating.
- Working on year-end numbers and possible reserve contributions in anticipation of the last meeting of the year
- Code review continues
- Plan to re-bid the Sweden Clarkson Community Center roof replacement after the first of the year.
- The Sweden Clarkson Community Center playground is complete, at no cost to the town. Monroe County ARPA funds were used for the project.
- The pension check to NYS was issued in the current abstract at an increase of approximately 18%.
- Attended the Supervisor's meeting. The new gas appliance restriction for new builds was discussed and is on hold for now along with the electric vehicle requirement for towns.

ACE CLEANER PROPERTY HEARING – 4626 Lake Road

At 6:15 p.m. Supervisor Hayles opened the hearing for condemnation of the property located at 4626 Lake Road. It is required by our Town Code for condemnation of a structure on a property, that the town notifies the owner of the intent to condemn and anyone who wishes to speak on the matter is invited to do so.

Background: On September 24, 2025 the Town of Sweden Code Enforcement Officers Robert LaPoint and Terry Ekwel declared the property unsafe due to lack of property maintenance for approximately 18 years, and the structural integrity and overall appearance of the building had deteriorated remarkably. When driving from the south you can see the roof has many holes and is ready to collapse.

The Town has been working with the NYS DEC for several years. They are preparing the site for demolition, pending the condemnation by the Town. Once demolished the NYS DEC will remediate the soil for contamination. This is good news for the Town of Sweden and will not cost the town any money. Supervisor Hayles does not have any answers as to what comes next for the site. There have been several questions regarding possible sale of the property. The town will not be involved in that. Back taxes are due to Monroe County.

If the condemnation is approved, demolition will begin next week. There is asbestos, so specialized contractors will perform the demolition.

Town Attorney Jim Bell stated that the notice of hearing was appropriately served upon the property owner, and a copy of the notice was filed in the Monroe County Clerk's office pursuant to Sweden Town Code, Chapter 54.

Hearing remains open.

- RESOLUTION NO. 144 Encumbrances

NOW, THEREFORE, BE IT RESOLVED:

Sec. 1. - RESOLUTION NO. 145 Approve Inter-municipal Snow and Ice Agreement with Monroe County

WHEREAS, the Town of Sweden and the County of Monroe entered into a Snow and Ice Control Agreement originally executed in 2023, under which the Town provides winter road maintenance services on designated County highways; and

WHEREAS, the 2023 Agreement provides that Monroe County shall issue annual rate adjustments for compensation to the Town for snow and ice control services; and

WHEREAS, Monroe County has issued the updated rate schedule for the upcoming winter season from October 1, 2025 through September 30, 2026 in accordance with the terms of the 2023 Agreement; and

WHEREAS, the Superintendent of Highways recommends that the Town Board enters into the agreement.

NOW, THEREFORE, BE IT RESOLVED:

Sec. 1. That the Town Board of the Town of Sweden does hereby accept the updates rates to the Inter-municipal Agreement for the Provision of Snow Removal and Ice Control Services from October 1, 2025 through September 30, 2026.

Sec. 2. That the Supervisor is hereby authorized to execute all necessary documents.

Sec. 3. That this resolution shall take effect immediately.

- RESOLUTION NO. 146 Amend Agreement with New York State
for Control of Snow and Ice

WHEREAS, the Sweden Town Board previously adopted Resolution No. 158-24 authorizing the Town Supervisor to enter into an agreement with the New York State Department of Transportation (NYSDOT) regarding control of snow and ice; and

WHEREAS, NYSDOT has proposed amendments to the original agreement to address funding due to exceeding estimated expenditures; and

WHEREAS, the Highway Superintendent has reviewed the proposed amendments and finds them to be in the best interest of the Town and recommends that the Town Board enters into the agreement.

NOW, THEREFORE, BE IT RESOLVED:

Sec. 1. That the Town Board hereby authorizes the Town Supervisor to execute the amended agreement with the New York State Department of Transportation for the 2025/2026 snow season, as proposed.

- RESOLUTION NO. 151

Increase CHIPS Funding and Expenditure
Appropriation in the 2025 Budget

WHEREAS, the Town of Sweden receives Consolidated Local Street and Highway Improvement Program (CHIPS) funding from the New York State Department of Transportation to support the maintenance and improvement of town roads; and

WHEREAS, updated state allocations for the 2025 fiscal year indicate that the Town of Sweden will receive a total of \$137,936 in CHIPS funding; and

WHEREAS, the 2025 Tentative Budget currently reflects \$129,000 in anticipated CHIPS revenue; and

WHEREAS, it is necessary and appropriate to amend the 2025 Budget to accurately reflect the revised state allocation and corresponding expenditures.

NOW, THEREFORE, BE IT RESOLVED:

Sec.1. That the Town Board of the Town of Sweden hereby approves increasing the 2025 CHIPS revenue line DB3501 from \$129,000 to \$137,936.

Sec.2. That the Town Board hereby increases the highway expenditure appropriation DB5112.2 – Chips Project by \$8,936, raising the total CHIPS-related expenditure from \$129,000 to \$137,936 for the 2025 fiscal year.

Sec. 3. That the Director of Finance is authorized to make all necessary entries and adjustments to the 2025 Town Budget to incorporate these changes.

Sec. 4 That this resolution shall take effect immediately.

WHEREAS, on November 12, 2025 a notice having been served upon the abovenamed subject property owner pursuant to Sweden Town Code Chapter 54 and said notice was also filed in the Monroe County Clerk's Office; and

WHEREAS, on November 25, 2025 a Hearing was held at the Sweden Town Hall, 18 State Street, Brockport, New York, at which time all individuals in relationship to this matter were heard.

NOW THEREFORE BE IT RESOLVED:

Sec. 1. As stated hereinabove, the Sweden Town Board does confirm its previous determination that the structure on the subject property is dangerous, is unsafe and therefore condemns the subject property.

Sec. 2. The Sweden Town Board hereby orders the immediate demolition and removal of the structure on the subject property as well as any remediation attendant thereto, same to be undertaken by the State of New York directly and/or through agents of the State of New York.

Sec. 3. This Resolution shall take effect immediately.
